GLOBAL FIRM IS FIRST CORPORATE TENANT JOINING THE BRIDGES IN DOWNTOWN ROANOKE

JDSU will occupy approximately 24,643 square feet in the Trolley Barn, located at 323 Walnut Avenue, and part of the overall redevelopment of The Bridges. The space, due for completion in December 2014, will feature an open, creative floor plan that once housed streetcar trolleys.
