The Seller was an entity controlled by Maryland-based Fernau LeBlanc Investment Partners. The Buyer was the Stewart Companies out of York, Pennsylvania. The sale represents Stewart's second acquisition in the region. In 2012, the Stewart Companies acquired the xTeriors plant in Doswell, securing the space for concrete products producer, NewLine Hardscapes, which has been in operation since the acquisition.
