 - Thalhimer associates participated in National Mentoring Month in January for a recruiting event to hear about BBBS’ one-to-one mentoring relationships. All proceeds from drink and food purchases at the event benefited Big Brothers Big Sisters.
 - Thalhimer associates volunteered at the office of Big Brothers Big Sisters and helped them organize their file room, assisted with mailing distributions, and moved office items.
 - The Thalhimer team of volunteers assisted and formed a team for BBBS’ annual premier fundraiser, Bowl for Kids’ Sake, at AMF Sunset Lanes on West Broad. Associates volunteered ahead of the event to help set up, as well as joined Team Thalhimer for a fun bowling event to celebrate their fundraising success. Team Thalhimer raised \$2,958 (beating their goal of \$2,000) for BBBS; and the event itself raised a total of \$102,700 (surpassing their goal of \$100,000).
