Formerly R.E. Lee High School, the property was originally constructed in 1926 and was converted in 2009, through the use of historic and new market tax credits, to 62 one- and two-bedroom independent senior living apartments with 30,000 square feet of commercial and amenity space.

An undisclosed purchaser acquired the asset on August 9, 2021, for \$4,750,000. John Pritzlaff and Jenny Stoner of Cushman & Wakefield | Thalhimer represented the seller and original developer, Gypsy Hill Place, LLC, in the sale.
